5. Membership

a) Qualification to become a member:

Membership will be open for those who wants to serve for Nature and society and should not have to any bad/criminals record.

b) Subscription, donation etc.:

All the members are liable to subscribe a lump sum amount as membership fees/subscription and donation may also be liable to subscribe towards the society, so fixed General Meetings from time to time.

c) Collection of fund:

The fund of the society will b collected from members/well-wishers, grant from any Govt./Organization and from its own resources, if any.

d) Control fund:

The fund of the society will controlled by opening account in the name of the society with any Nationalized Bank or Post Office, which shall be operated with the joint signature of the President and Secretary or propose by the Executive or General Meetings resolution of the society.

6. Procedure of the General Meeting:

The General Meeting will be at least once in a year.

7. Quorum of the General Meeting:

In presence of 2/3rd members of the total members, the quorum of general meeting will be formed, but no quorum in case of adjourned meting is needed so far.

8.Election procedure of Executive Committee:

The Executive Committee will be constituted through democratic procedure amongst the members of the society in any General Meeting.

9. Short description of the Executive Meeting:

Primarily the Executive Committee consisting 7 (seven) members which includes the one President, one Secretary, one Co-ordinator and rest is the Executive members subjects to increase in due course, if felt needed.

10. The term of the Executive Committee:

The term of the Executive Committee will be 3 (three) years, subject to increase in due course if felt required.

11. Procedure of Re-election committee:

If necessary, Re-election will be held according to the Election procedure.
